

1. SETTLEMENT

3. PLACE

4. OBJECTS

- c) To open, found and establish research and training centers and to provide necessary facilities or to contribute to educational and scientific research development in any place as the trust deems fit.
- d) To engage teachers, professors, instructors and experts of good moral character and capable to impart efficiently and economically up to date instruction in modern science, industrial, advocates, research work, intellectual and other usual pursuits.
- e) To assist, finance, felicitate, support and or help, give reward, allowances and other financial assistance to promote education.
- f) To establish found and maintain libraries, reading rooms, and auditoriums for advancement of education.

b) To organize hold and/or arrange debates, lectures, seminars, other cultural and literary programs, conferences, performances, functions and social gatherings and to invite poets, singers, artists and other learned persons to participate therein.

h) To build, maintain and run hostel facilities and boarding houses for students.

i) To promote Child & Women Welfare.

j) To explore ways for promotion of socio economic development.

k) All objects of the trust herein stated above shall come into effect after necessary appointment of the competent government authority in the case where affiliation/permission /sanction is required.

l) The trust will never engage in act which are illegal and unlawful in nature and also oppose to the public policy and contrary to the law of the country.

m) The trust will never engage in acts like micro financing and Money Laundering and shall not obtain any donation or like that from abroad without getting the permission of FEMA Act from the Central Government /the Competent Government authority.

PROVIDED the Trust may assist/donate the other TRUST to carry out the various objects mentioned in the objects clause in such manner and the extent the Trustees may decide upon from time to time.

5. BENEFIT OF THE TRUST

The Trust "GIRI EDUCATIONAL TRUST" shall be a public charitable trust. The benefits of the Trust shall be open to all irrespective of caste, creed, religion, race, sex etc.

6. FUNDS

The Trustees may accept donations, grants, subscriptions, aids or contributions from any person, Government, Local authorities or any other institutions, in cash or in kind including immovable property without any encumbrance, but the Trustees shall not accept any receipt with any condition or terms inconsistent with the objects of the Trusts. While applying such receipts to the objects, the Trustees shall respect the directions, if any, by the granter. Any receipt with specific direction to treat the same as part of the corpus of the Trust or separate fund shall be funded accordingly.

7. INVESTMENTS

a) All monies, which shall not immediately required for current needs shall be invested by the Trustees in eligible securities and investments, or in banks. Such investments shall be in the name of Trust or Trustees.

b) ~~That the trustees shall invest the trust fund, carry on any business with the trust fund and /or enter into partnership on behalf of the trust, as they may deem fit.~~

c) That the trustees shall manage the trust fund and investments thereof as a prudent man would do the same. They shall recover all outstanding and meet all recurring and other expenses incurred in the upkeep or management thereof.

8. APPLICATION OF INCOME TAX ACT, 1961 AND TRUST FUND

The Trustees shall be empowered to invest the funds of the Trust in such manner as they deem fit for the sole purpose of the objects of the trust provided that such investments shall be in accordance with the provision of the Income Tax Act, 1961 as well as of any other law for the time being in force as are applicable to public educational trusts.

9. POWER OF THE TRUSTEES

The Board of Trustees shall have the control and management of the Trust and exercise the following powers:

- a) To determine from time to time to commence and to take up the object and purposes for which the funds of the trust shall be used and allot and allocate to each of the objects such portion of the funds as they deem fit;
- b) To purchase and acquire any immovable property of any kind for this object of the Trust or as a source of income for the Trust;
- c) To sell, mortgage, or dispose of any immovable property/properties belonging to the Trust;
- d) To incur all expenditure necessary as in their own opinion useful for carrying out the objects and administration of the trust;
- e) To sell, lease, mortgage or dispose of any property, immovable property/properties belonging to the Trust
- f) To open one or more bank accounts of the trust with any bank or banks as the Trustees may deem fit and deposit monies of the Trust in the Bank accounts.

- g) To borrow for and on behalf of the Trust with or without security from banks, Governments, Universities or any other government Body/bodies both central and state;
- h) To appoint/ nominate/ remove any member from the board of trustees only with the consent/ vote of atleast three-fourth majority of the total members constituting the board excluding the trustee being appointed/ nominated or removed.
- i) To take such policy/ decisions with respect to the working of the trust including but not limited to appointment of auditor, remuneration of trustees, holding of meetings and such other activities for smooth and efficient functioning of the trust.
- j) To employ staff of all kinds necessary and useful for carrying out the objects of the trust.
- k) To incur such other items of expenditure as is necessary and incidental for carrying out the objects of the Trust;
- l) To institute, conduct, defend, compound, withdraw, compromise, adjust, refer to arbitration or to do such things as are incidental and necessary, concerning the affairs of the Trust and to sign and verify vakalatnamas, pleadings, affidavits and other powers;
- m) To accept contributions in cash or in kind either by way of addition to the trust funds generally or for any one or more of the specified objects of the Trust.
- n) To establish as many adhoc committees for any purpose.

10. DISQUALIFICATIONS OF TRUSTEES

A trustee shall be disqualified from becoming Trustee, if he/she-

- a) Absents from 2 consecutive meetings of the Trustees or from all meetings of the Trustees for a continuous period of one year, without obtaining leave of absence, or
- b) Continuously neglect his/her duties or commits any breach of Trust, or
- c) Misappropriates the Properties / Funds of the Trust, or
- d) Is convicted of an offence involving moral turpitude, or
- e) Is declared insolvent and bankrupt by any competent court.

MEETINGS OF THE TRUSTEES

The Managing Trustee shall preside over all the meetings of the trustees and in his absence the Joint Managing Trustee shall preside such meeting and in the absence of both, the trustees attended such meeting may elect any one of them to preside over the meeting;

The meetings of the Trustees may be convened by the Managing Trustee or under his direction by any other Trustees.

The quorum of the meeting of the Trustees shall be 2 personally present.

In the event of equality of votes, the person presiding such meeting shall exercise casting vote (additional vote).

12. RESOLUTIONS

The Trustees may exercise all the powers vested in them in the above clause under these presents by resolution passed by a simple majority of the trustees attending such meetings of the Board of Trustees.

Any resolution in writing signed by all Trustees holding office for the time being shall be valid and binding.

13. ADMINISTRATION OF THE TRUST

- a. The administration of the TRUST shall vest with the Board of Trustees. For proper administration the Trustees may appoint the following personnel or office bearers of the trust, either amongst themselves or any third person, for its efficient working:
 1. President
 2. Vice President
 3. Secretary
 4. Treasurer
- b. For appointment of any third person as the above-mentioned personnel, a unanimous consent of the Trustees shall be obtained.
- c. The Board of Trustees shall, if required, with unanimous consent appoint such other office bearers or personnel as they may deem fit and proper for and provide for such designations as they may decide for proper working of the Trust.
- d. The role and responsibilities of any other office bearer, as may be appointed by the Board of Trustees shall be defined by them. The Board of Trustees shall have the power to delegate such power or define the roles and responsibilities of the office bearers as they may deem fit and proper, for carrying out the workings of the Trust.

OFFICE BEARERS

The Roles, Responsibilities and Powers of all the office bearers are defined below. In addition to these, the Board of Trustees may grant additional roles, responsibilities and powers to any of the Trustees as and when required.

a) President:

In addition to discharging normal duties of a trustee, the President will be authorized to sign all documents, including bank documents, acknowledgements for the contributions received, and agreements with individuals, government institutions and other organizations on behalf of the Board of Trustees to give effect to decision of the Board. The President along with the Board of Trustees is responsible for ensuring that the Trust pursues its objects and for maintaining the dignity of the Trust organization and shall use his/her influence to promote the activities of the Trust.

b) Vice President:

The Vice President shall discharge the duties of the Managing Trustee, in the absence of the Managing Trustee of the Trust and shall have the power and authority delegated and assigned to him/her by the Managing Trustee.

c) Secretary:

The Secretary shall maintain the records of the organization, prepare and circulate agenda and minutes of Board of Trustees meeting. The Secretary shall be also responsible for the day to day administration activities of the Trust. The Secretary shall deal with correspondence received by the Trust, send replies in consultation with the Managing Trustee, Vice President and/or the Treasurer where necessary. He/she is responsible for the safe custody of all the assets and records of the Trust. The Secretary shall represent the Trust in all legal matters, sign the papers related to legal cases, attend to courts or represent the Trust in Government offices.

d) Treasurer:

The Treasurer will prepare Annual Budget; monthly and yearly expenditure statements get the same audited by auditor duly appointed by the Board of Trustees and place them before the Board of Trustees for approval. The Treasurer is responsible to maintain cash book and prepare vouchers for the payments made, receive contributions, sign acknowledgements for the amounts or articles received by the Trust and prepare monthly and yearly statements of revenue and expenditure, as well as, the register of assets of the Trust and place them before the Board of Trustees for their approval. The Treasurer is responsible for safe custody of cash, bonds, securities etc. of the Trust.

POWER TO ALTER RULES AND REGULATIONS

The Board of Trustees shall have full power and authority to make, alter and rescind rules and regulations for the management and administration of the Trust. Any amendment to the Trust Deed will be carried out only with the approval of the Commissioner of Income Tax.

16. REMUNERTION TO THE TRUSTEES

The Trustees would be entitled to receive remuneration as may be decided by the Board from time to time. They shall also be entitled to out of pocket expenses incurred by them in the course of discharging the functions of the Trust. Further the Income and funds of the Trust will be solely utilized towards the objects and no portion of it will be utilized for payment of Trustees by way profits, interest, dividend or otherwise.

17. INDEMNITY

Every Trustee shall be indemnified out of the fund in respect of any loss arising from or contingent upon any investment made out of the monies of the Trust unless such loss shall have been occasioned by own negligence and also every Trustee shall be indemnified out of the Trust against all proceedings, suits, claims, costs, damages and expenses occasioned by any claim in connection with the matters or affairs relating to the Trust created by these presents or in the exercise of powers or discretion vested in them by virtue of these presents.

18. BANKING ACCOUNT

All income, subscription and pecuniary donations for the general purposes of the Trust and the income, investments and all other money from time to time forming part of the general revenue of the Trust shall on the same being received be paid into a banking account with any scheduled bank for the purpose of the Trust. The bank accounts shall be operated by either of the trustees.

19. ACCOUNTS AND AUDIT

1. The Trustee shall keep proper books of account of the all the assets, liabilities and income and expenditure of the Trust and shall prepare an Income and Expenditure Account and Balance Sheet for every year as on the last day of March.
2. In case the income of the trust exceeds the limit as per the provision of the Income Tax Act, 1961, the accounts of the trust shall be audited by a Chartered Accountant or a firm of Chartered Accounts who shall be appointed for that purpose by the Trustees and the audited accounts shall be placed at a meeting of the Trustees, which shall be held before the end of the succeeding year.

VACANCY OF TRUSTEES FROM THE BOARD

Where any vacancy arises in the Board of Trustees, on account of death, incapacity or on being disqualified as per Clause 10 of this deed, the remaining trustees shall fill in the vacancy by appointing any person by unanimous vote of all the remaining trustees

21. CESSATION OF TRUST

The Trust shall endure in perpetuity unless it is terminated by unanimous resolution of the Trustees to this effect.

22. AMALGAMATION

The trustees may amalgamate the trust with another Trust or Institution having similar objects.

23. DISSOLUTION

In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed amongst the Trustees but the same shall be transferred to some other similar Trust/ Society/ Non Profit Company whose objects are similar to those of this Trust.

24. JURISDICTION

The transactions shall take place in Kolkata and it is agreed between the parties that Courts at Kolkata shall have jurisdiction to entertain any dispute arising out or in any way touching or concerning this Trust Deed.

25. APPLICATION OF TRUST ACT, 1882


